




### Running total of service charge revenue




# Actual vs. Budgeted Revenue by Billing Parameter 2020 – YTD




# Actual vs. Budgeted Revenue by Billing Parameter 2020 – Quarter 4



### Revenue Shortfall Projections by Month




## Actual vs. Projected Flows





## Monthly Plant Flows (2017-2020)




