Recent Project Activities


Field survey work (topographic surveys, soil borings, geologic surveys, archaeological surveys, wetland delineations and tree cataloging) began on May 9th, 2005 throughout the drainageway corridor from Mineral Point Road in the Town of Middleton down to Edward Street in the City of Verona. Work on these surveys continued throughout the summer of 2005. Reports of these survey results have been compiled and distributed to the Madison Metropolitan Sewerage District, City of Verona, Town of Verona, Town of Middleton, and City of Madison.

Segment 3 consists of both a sanitary sewer interceptor (~15" to 30" pipe) and drainageway design from Mineral Point Road to Midtown Road, including one branch section from South Point Road to Valley View Road and another from Soaring Sky run to the Bruce Company property.

Segment 2 consists of a sanitary sewer interceptor (~24" to 30" pipe) design from Midtown Road to CTH PD.

Segment 1 consists of a sanitary sewer interceptor (~27" to 36" pipe) design from CTH PD down to Edward Street.

The preliminary design of the sanitary sewer interceptor through all segments, (and drainageway through Segment 3) has been completed and awaits public involvement prior to completion of final plans.
